COVID-19 WAIVER & RULES ACKNOWLEDGEMENT

(Required for Participation in Hoops for Scoops Youth Basketball Clinic)

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID -19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an individual can be infected with COVID-19 without their knowledge and be asymptomatic. Family YMCA of N/W IL has put in place preventative measures to reduce the spread of COVID-19. However, Family YMCA of N/W IL cannot guarantee that I or anyone else will not become infected with COVID-19, including my spouse, guests, unborn child, or relatives. Participation in the Hoops for Scoops March-April 2021, a Family YMCA of N/W IL event and activity, could increase the risk of contracting COVID-19. By signing this agreement, I ACKNOWLEDGE the contagious nature of COVID-19 and VOLUNTARILY ASSUME THE RISK that I may be exposed to or infected by COVID-19 by participating in a Family YMCA of N/W IL event(s) or activity, and that such exposure or infection may result in personal injury, illness, permanent disability, and death to myself, my spouse, guests, unborn child, or relatives.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Hoops for Scoops, a Family YMCA of N/W IL event and activity, may result from the actions, omissions, or negligence of myself or others, including, but not limited to, Family YMCA of N/W IL members, Family YMCA of N/W IL staff and Board members, and event participants.

I UNDERSTAND AND VOLUNTARILY ACCEPT AND ASSUME ALL the foregoing risks related to COVID-19 and accept sole responsibility for any injury or illness that may occur. Further, I UNDERSTAND AND AGREE that this release includes any Claims based on the actions, omissions, or negligence Family YMCA of N/W IL members, Family YMCA of N/W IL staff and Board members, volunteers, and event participants, whether a COVID-19 infection occurs before, during, or after participation in the March-April Hoops for Scoops, a Family YMCA of N/W IL event and activity, or any Family YMCA of N/W IL event and activity.

- **Parents will need a signature to drop off and pick up for each practice. Due to guidelines spectators ca not sit and wait. (No Spectators Allowed).**
- **Masks have to be woren by players and coaches**
- **Breaks for masks will be taken during practice.**
- **If anyones has sympstoms or a temp will have to stay home. Parents temps taken as well.**
- **Basketballs will be given out, participants will have to play with their own ball and bring back for each day.**
- **We will have hand santizers available as well.**
- **Participants will need to bring own water bottles.**
 - **3/4th participants will leave outside shoes by front desk on designated areas. This includes coaches and employees changing as well.**
